What is WARN?

A Water/Wastewater Agency Response Network (WARN) is a network of utilities helping other utilities to respond to and recover from emergencies. The mission of WARN is to provide expedited access to specialized resources needed to respond to and recover from natural and human caused events that disrupt public and private drinking water and wastewater utilities.

Who can use WARN?

Any public or private drinking water or wastewater utility can participate in WARN, regardless of

What are the steps for accessing and using WARN?

- 1. Analyze the situation, determine your resource needs, and decide whether mutual aid/assistance is needed.
 - Attempt to access local resources first. If the situation requires resources beyond those available at the local level, contact WARN to access resources from additional utilities throughout the state.
 - Be sure to notify your local emergency management agency of your need for mutual aid/assistance.
- 2. Be specific in your resource requests. Refer to the AWWA *Water & Wastewater Mutual Aid & Assistance Resource Typing Manual*¹ for help in accurately describing the resources you need.
- 3. Contact WARN to formally initiate a request.

 - See the WARN Emergency Notification Form on the following page for the type of information you will be asked to provide concerning your request.
 - Be sure you understand and agree to adhere to the procedures and standards set forth by the WARN Mutual Aid and Assistance Agreement, as it outlines terms for issues such as liability, workers' compensation, and reimbursement. Your WARN representative can provide you with a copy of the Agreement.
- 4. If a WARN member offers to provide assistance, be sure to obtain an estimate of their costs and discuss the terms of deployment. You as the requesting utility have final approval of acceptance of the aid/assistance.
- 5. Identify a person at your utility to manage all incoming mutual aid/assistance resources, including care, feeding, and other support for all personnel.
- 6. Notify your local emergency management agency to inform them of the arrangements for the incoming resources.
- 7. Consider how to integrate incoming mutual aid/assistance resources with your existing workforce and identify work assignments for teams to carry out.
- 8. Develop a demobilization plan that includes protocols on how and when mutual aid/assistance resources will be released.
